Call to Order

President Anderson called the meeting to order at 10:00 a.m. and led the Pledge of Allegiance.

Information Items

1. Tug Dominion Update – David Prater, Washington State Department of Ecology Liaison

CEO Rothlin introduced David Prater, Department of Ecology (DOE) Liaison Officer. Mr. Prater acknowledged the virtual presence of Nora Haider from DOE and LCDR Sean DiGeorge of the U.S. Coast Guard (USCG). Mr. Prater provided detail on the Tug Dominion which sank at Bremerton Marina on September 17, 2025, and presented a timeline of the response actions since the sinking which included two unsuccessful attempts to lift the tug. The response is now transitioning to a maintenance phase while the Unified Command approves next steps. In response to a question regarding damage to the breakwater, Kathy Garcia, Marina Operations Manager, explained there is no current damage but due to the new position of the Tug, some strain has been noticed. The Port is working closely with our engineers and a naval architect to confirm the structural integrity of the breakwater.

Mr. Prater discussed the containment and cleanup actions along with wildlife assessment and recovery. He also detailed the local impacts to marina tenants, public access to marina being restricted, cruise ship docking, and marina traffic being restricted. He noted that a claims line has been established via the USCG National Pollution Fund.

Mr. Prater listed the four potential paths forward of 1) destruction in place; 2) destruction under Washington Department of Natural Resources (WA DNR); USCG removal of vessel via marine debris authority; and bringing in a larger crane.

LCDR DiGeorge discussed in detail the four options and potential drawbacks. He responded to questions and comments from the Board and provided closing comments.

Mr. Prater and Ms. Garcia responded to questions and comments from the Board.

2. Sunny Jack Events, LLC Report – Sunny Saunders, Founder

Ms. Garcia spoke to Ms. Saunders' cooperation and partnership through the Dominion situation as she had to cancel her final Friday Night Market at a cost of over \$3,500.

Ms. Saunders provided a 2025 event recap, highlights, vendor stats, and tourism analytics on Bremerton Bridge Blast; Bremerton Night Market; Taste of Kitsap; and Bremerton Blackberry Festival. She described Sunny Jack's partnership with the Port noting that all these waterfront events greatly increased overnight guest boater stays at Bremerton Marina with 300+ visiting boats during Bridge Blast. Erica Filler, Marketing & Communications Manager, described how the Port markets these events.

Ms. Saunders provided detail on her newly created non-profit, Elevate Events, and how Sunny Jack Events will partner with Elevate. She discussed the potential for a new 2026 waterfront event, Discover Bremerton, June 20-21, that will coincide with the FIFA World Cup timing.

The Board expressed their appreciation for all her hard work stating her efforts make a huge impact on downtown Bremerton.
