# **Information Items**

1. Legislative Update – J. Dylan Doty, Doty & Associates, Inc.

Mr. Doty provided the Board a detailed written report on the 60-day "short" legislative session that was adjourned on time on March 8. Highlights included:

- Carbon tax did not pass; however, there will be an initiative to the people on the ballot in November.
- Election year for all members of the house and half of the senate; it will be a very hard fought campaign season.
- \$1.019M for the Port Orchard Marina Breakwater Refurbishment was included in the capital budget along with money for Mason County's study for a sewer extension.
- Belfair Bypass was renamed SR3 Freight Corridor.
- Several bills listed in the written report were discussed.
- Previewed 2019 and beyond; he encouraged the commissioners and staff to look at the capital facilities plan and put ideas together now for what to ask for next session.

In response to commissioner and staff questions, there was discussion on several topics including state versus local school district taxing; potential partnerships in other regional projects of interest; Tacoma Narrows Bridge toll cap; and Belfair sewer extension.

2. Human Resources Update – Larry Boone

Mr. Boone introduced himself and provided a brief overview of the human resource services he has been providing the Port. He reviewed his professional background that qualifies him to provide those services and described the projects he is currently working on such as updating the employee handbook and labor relations. He reported that labor negotiations are beginning for a new 3-year contract with a goal of reaching a mutually agreeable contract done in a manner that will strengthen and build trust and respect from represented employees.

# **Citizen Comments**

Roger Gay, South Kitsap

- Spoke to his support of SB 6034 passing which authorizes public utility districts such as Kitsap Public Utility District (KPUD) to petition for retail telecommunications services. Suggested the Port look at partnering with KPUD.
- Spoke to the Puget Sound Regional Council (PSRC) competition for regional transportation funding in which there are two Kitsap County spots left open and suggested the Port look at what funds are available and have projects on the hotlist ready-to-go. Commissioner Strakeljahn responded that the Port is always tracking what may be eligible for that funding and we continue to stay on it.

#### Jim Rothlin, Chief Executive Officer

• He discussed the Navy's plan for expanding the scope of their special operations training in the region and provided detail on some of that training. It is estimated the Navy will make a decision on whether to proceed with the proposed training schedule sometime in late summer/early fall. The Port has extended an invitation to Naval Special Operations

to possibly include Port of Bremerton waterfront properties as an option for their training.

- Announced that April 7 will be the grand opening for new marina tenants, Freedom Boat Club. He described the club's time-share boating program and indicated the club will make a presentation on their program at the next board meeting.
- Along with Business Development Director, Arne Bakker, met with Bremerton Mayor Greg Wheeler and provided him a virtual tour of port properties and how the port benefits economic development goals. Was invited to make the presentation to city staff and council.
- Lease updates:
  - In process of finalizing a lease with Skookum for a short-term lease for a portion of Olympic View Industrial Park (OVIP) Building #1
  - Received two lease applications for the Avian building upper level
  - Working on a 30-year lease for a manufacturing facility with the expectation of up to 100 employees
- With continued demand for increased IT support, the Port has contracted with Kitsap Networking Services (KNS) allowing for more flexibility. This ends a long-term agreement with West Sound Utility District (WSUD) and their IT specialist, Michael Whitehead who spearheaded and was responsible for our growth of infrastructure at the Port over the last 12 years. He thanked Mr. Whitehead and WSUD for their services.
- Discussed previous meeting with regional director, Larry Phillips, of Washington State Fish & Wildlife regarding potential improvements for Misery Point boat launch. Received a phone call from Mr. Phillips regarding partnering and moving forward on this project.

# Commissioner Strakeljahn

- Reported on the recent Kitsap Regional Coordinating Council (KRCC) meeting during which it was discussed that PSRC's VISION 2050 plan was opened up for comments. He stated the Port has submitted comments and the KRCC Executive Committee will meet later this week to solidify all the regional comments.
- Attended a U.S. Global Leadership Coalition breakfast with a panel discussion that included Congressman Derek Kilmer. He reviewed detail of the discussion and the importance of being internationally aware.
- Called on Chief Operations Officer Fred Salisbury who provided more information on the PSRC transportation regional competition cycle and how the Port is preparing to apply for that funding.

#### Summary:

SuperCritical Technologies, Inc. leases the property at 5747 Imperial Way SW in the Olympic View Industrial Park. The premises consist of approximately 6,000 square foot building on a .63 acre parcel. This lease currently runs through May 31, 2019, with nine (9) two (2) year options remaining on the lease.

SuperCritical Technologies, Inc. wish to convey and assign existing lease to Chal Davidson, and his company, 5747 Imperial Way SW LLC. Staff believes assigning the rights and control directly to Mr. Davidson will improve the overall opportunities at this site.

The Lessees are requesting consent to the assignment and transfer to 5747 Imperial Way SW, LLC of all the Lessee's interests in the leases and amendments.

The consent and assignment documents have been reviewed by the Port Attorney.

#### Fiscal Impact:

Since the lease is a direct assignment with no changes to the current lease payment schedule, there is no fiscal impact for this action. However, staff believes the likelihood that the options being acted upon is more favorable with this assignment. A financial review has been completed with the new lessee and approved by accounting staff.
