#### **Bremerton Economic Development Corporation Meeting**

With no further business to come before the Corporation, the BEDC meeting was adjourned and the Public Meeting reconvened at 6:33 p.m.

#### **New Business**

1. Commissioner appointments/representation for 2018

CEO Jim Rothlin highlighted the revisions from the 2017 list. Following discussion, it was determined that the list would remain the same except for the following: Commissioner Strakeljahn will serve as representative and Commissioner Bozeman as alternate on the new Kitsap Regional Coordinating Council (KRCC) Land Use Planning Policy Committee and the Puget Sound Regional Council Economic Development Board.

2. Confirmation of the regular business meeting schedule for 2018

CEO Rothlin discussed revising the regular business meeting schedule to hold one day and one evening meeting explaining some of the benefits of the alternate schedule. Following discussion and public comment it was determined to move the first meeting of the month to 10:00 AM and reevaluate after three months. The meetings will continue to be held on the 2<sup>nd</sup> and 4<sup>th</sup> Tuesdays of every month with the 2<sup>nd</sup> Tuesday meeting at 10:00 a.m. and the 4<sup>th</sup> Tuesday meeting remaining at 6:00 p.m.

#### **Staff Reports**

Jim Rothlin, Chief Executive Officer

- Staff met with Congressman Derek Kilmer to reintroduce him to Port projects and other activities the Port is involved with.
- Along with Commissioner Strakeljahn, met with Department of Fish & Wildlife Regional Director Larry Phillips to introduce him to the Port and discuss potential Misery Point boat launch improvements. Will meet again in February.
- Gave a presentation at a Kitsap Commercial Investment Brokers (KCIB) meeting and introduced Director of Business Development Arne Bakker who will attend those meetings in the future.
- Contract has been signed for site development for new corporate hangars.
- On January 2, over 225 moorage reservations were made for the 2018 holiday weekends. That was the first day holiday reservations are accepted for the current year.
- Seattle Boat Show will be held January 26 thru February 3 and the Port will again showcase Bremerton and Port Orchard Marinas at the show. He discussed the value of participating in the show.
- Recently signed leases with tenants in the industrial park; International Marine and Industrial Applicators are a new tenant and International Flooring extended their current lease. Also in discussions with three other potential tenants.

Commissioner Bozeman suggested presentations such as the one given to KCIB also be given to the Bremerton and Port Orchard city councils.

#### **Commission Reports**

#### Commissioner Strakeljahn

• Legislature is back in session and it could prove to be exciting. The Port still has items such as the Port Orchard Marina breakwater in the capital budget.

#### Commissioner Bozeman

• Would like staff to continue working with Bremerton on the extension of Airport – Industrial Way. Even though legislators tell you there is no money, the right project just needs to be put in front of them and lobby it hard. It is important to keep them informed on what we need funding for and keep pushing.

#### Commissioner Stokes

• Stated A&W in Port Orchard hosted antique cars on Wednesday nights but with A&W closing, they are looking for a new location. He asked Roger Jensen of Saints Car Club to speak to that. Mr. Jensen provided some background on the club and their community support. He reiterated that they are looking for a new location for the spring/summer Wednesday gatherings of the antique cars and explained the potential benefits for locating at the airport. The Commissioners expressed support for being the host location and requested staff examine the potential and come back with recommendations.

#### **Summary**:

On December 11, 2017 the Port published a Request for Statement of Interest and Qualifications for Airport Consulting Services to provide aviation related design and engineering services to the Bremerton National Airport for a period not to exceed five (5) years in accordance with procedures set forth in FAA Advisory Circular 150/5100-14 Architectural, Engineering, and Planning Consultant Services for Airport Grant Projects. The Airport has one programmed FAA project in 2018: the preliminary engineering and design of the airfield lighting project.

Six companies submitted SOI/Qs: Precision Approach, DOWL, Reid Middleton, PND, Century West, and Berger ABAM. A selection board consisting of the COO, Airport Manager, Airport Maintenance Lead, Yakima Airport Director and Arlington Airport Operations Coordinator reviewed, graded and ranked each proposal. The top three firms: Century West, DOWL and Precision Approach were invited to interview. An interview board consisting of the COO, Airport Manager, Airport Maintenance Lead and Director of Business Development completed the interviews on January 19. Based upon the SOI/Q submitted, the interview, and due diligence completed, Port staff will be deciding on the recommended engineering firm on Monday, January 22 and will present the recommendation at the commission meeting on January 23.

#### **Fiscal Impact**:

None. The airfield lighting preliminary engineering and design project is identified and funded in the 2018 Airport Capital budget.

#### Recommendation:

Staff recommends the selection of the recommended firm for Airport Consulting Services for a period not to exceed five (5) years.

#### **Motion for Consideration:**

Move to approve the selection of the firm to be determined for Airport Consulting Services and authorize the CEO to execute the consultant agreement.
